and

WHEREAS, R.J. Walsh Associates Inc., P.O. Box 119 Allentown, NJ has provided a proposal to provide
remediation services per the attached proposal in the amount of \$16,110.00; and

WHEREAS, the amount quoted by R.J. Walsh Associates, Inc. is based on the New Jersey State Contract
and therefore, does not require advertisement for a bid; and

WHEREAS, the Township has provided for this purchase in the Capital Improvement Ordinance #2019-03;
and,

WHEREAS, the Township's Chief Financial Officer certifies funds are available in the Capital Improvement
Ordinance #2019-03, line item C04-55-217-001 for this purpose.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Shrewsbury,

\$16,110.00 be and is hereby awarded to R.J. Walsh Associates Inc., P.O. Box 119 Allentown, NJ 08501

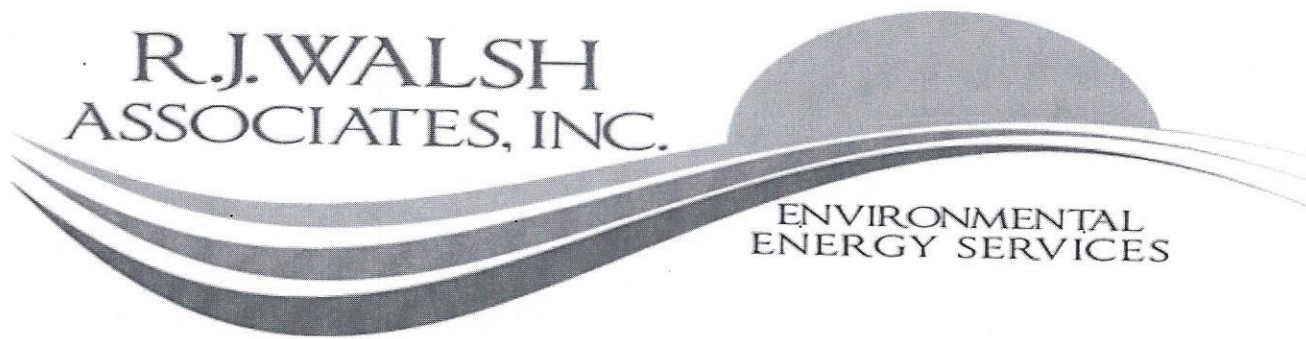
BE IT FURTHER RESOLVED that the Mayor be and is hereby authorized to execute said Contract.

Re: Remediation Services

RJW proposes to fulfill the following Scope of Work under NJ State contract including the following line items:

1. Excavate an area of approximately 14 ft. by 16 ft. by 13 ft. bgs and at the direction of Maser Consulting or until PID readings and field observation deem impacted soils have been removed. Place soil on 6 mil plastic.
2. Dispose of approximately 40 tons of impacted soil required to be remediated from 8 ft. to 13 ft. below surface grade within the excavation area (provide per ton cost). \$64.80/ton
3. Maser Consulting will collect post excavation soil samples following soil remediation.
4. Place and compact Dense Graded Aggregate (DGA) in 12-inch lifts fill to replace petroleum impacted soil. DGA material must be certificated clean fill and certification must be provided before material is placed on site. Place and compact excavated material from surface to eight (8) ft in 12 inch lifts to surface.
5. Remobilization to load soil into trucks for off site disposal

Cost for above - \$16,110.00

1. Place and compact extra fill (per ton cost). - \$49.60/ton
2. Dispose of impacted soils greater than 40 tons (per ton cost) - \$64.80/ton
