RESOLUTION APPROVING CONTRACT FOR DRUG TESTING AND SCREENING SERVICES AND AUTHORIZES THE AWARD OF CONTRACT TO CENTRAL JERSEY URGENT CARE OF EATONTOWN WITH THE TOWNSHIP OF SHREWSBURY

WHEREAS, Shrewsbury township has a need for drug testing and screening services due to the provisions of State Statute; and

WHEREAS, the Chief Financial Officer has determined and certified in writing that the value of the services will not exceed \$17,500.00; and

WHEREAS, the anticipated term of the contract is one year, unless terminated earlier or not terminated on its anniversary date; and

WHEREAS, Central Jersey Urgent Care of Eatontown has submitted a proposed contract indicating that they will provide drug screening and testing services required for an amount not to exceed \$55.00 per screening, and based on the number of employees and likelihood of use of such services, it is unlikely to exceed the estimation of the Township of \$1,000.00 per year. A true copy of said contract is attached hereto as Exhibit "A"; and

WHEREAS, Central Jersey Urgent Care of Eatontown has submitted, or will submit prior to execution their Business Registration Statement concerning payment of taxes in the State of New Jersey; and

WHEREAS, the Chief financial Officer has certified the availability of funds not to exceed One Thousand Dollars (\$1,000.00) for said services under budgetary line item entitled "Administrative & Executive – Other Expense". A copy of said Certification of Availability of Funds is on file in the Clerk's Office of Shrewsbury Township.

NOW, THEREFORE BE IT RESOLVED by the governing body of the Township of Shrewsbury, Monmouth County, New Jersey, that the governing body hereby approves of the contract with Central Jersey Urgent Care for Drug Testing and Screening Services, and authorizes the Mayor to execute said Contract with the Clerk attesting to the execution of said Contract for a term commencing August 1, 2021 and ending July 31, 2022; unless not terminated by the parties per the attached Contract as Exhibit "A".

BE IT FURTHER RESOLVED, that the Business Registration Statement and Certification of Availability of Funds shall be on file in the Clerk's Office of Shrewsbury Township.
