RESOLUTION AUTHORIZING PROFESSIONAL CONTRACT WITH COLLIERS ENGINEERING AND DESIGN FOR PROFESSIONAL ENGINEERING AND CONSTRUCTION SERVICES FOR BARKER AVENUE ROADWAY IMPROVEMENTS – PHASE II

WHEREAS, the Township of Shrewsbury is in need of professional engineering and construction services for the improvements of Barker Avenue from 300 ft. south of Belshaw Avenue to the end of the improved roadway; and

WHEREAS, partial funding for the project is being provided by the NJ Department of Transportation (NJDOT) through a Municipal Aid Grant in the amount of \$100,000.00 and additional funding may be required to complete all of the proposed improvements estimated at \$140,000.00, and engineering costs provided by this Resolution; and

WHEREAS, a portion of the project will also be funded by Capital Ordinance 2021-05; and

WHEREAS, engineering costs were provided by the proposal of Colliers Engineering and Design, dated December 9, 2021, which is available in the Clerk's Office of Shrewsbury Township for review providing for engineering specifications and services in the amount of \$27,300.00; and

WHEREAS, the Chief Financial Officer recommends the aforesaid proposal of December 9, 2021 from Colliers Engineering and Design for engineering services for the New Jersey Department of Transportation Municipal Aid Grant known as Barker Avenue Roadway Improvements – Phase II.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Shrewsbury, County of Monmouth, and State of New Jersey, that the Township Committee hereby authorizes a contract for engineering services for Barker Avenue Road Improvements – Phase II per the proposal of Colliers Engineering and Design of December 9, 2021, available in the Clerk's Office of Shrewsbury Township in the amount of \$27,300.00, per Bond Ordinance No. 2021-05.

BE IT FURTHER RESOLVED, that the Chief Financial Officer hereby certifies the funds shall be available from Capital Ordinance No. 2021-05. Said Certification is available in the Clerk's Office of Shrewsbury Township.

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized the sign the aforesaid Contract with Colliers Engineering and Design prepared by the Township Attorney or reviewed by the Township Attorney for the above referenced services.
