RESOLUTION OF THE TOWNSHIP COMMITTEE AUTHORIZING THE TRANSFER OF THE YEAR 2022 MUNICIPAL BUDGET APPROPRIATIONS AS PER N.J.S.A.40A:4-58.

WHEREAS, it is anticipated that it may become necessary to expend funds in excess of the amounts specified in the year 2022 Municipal Budget for certain appropriation accounts while other appropriation accounts have appropriations in excess of that required; and

WHEREAS, N.J.S.A. 40A:4-58 and 40A:4-59 permits a municipal Governing Body to transfer funds from appropriation accounts deemed to have an excess in appropriations to those accounts that are deemed to be insufficient during the last two (2) months of the fiscal year or the first three (3) months of the succeeding fiscal year provided that said transfers be authorized by resolution adopted by not less than two- thirds of the full membership of the Governing Body; and

WHEREAS, the Township Chief Financial Officer has recommended that these transfers be authorized.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Shrewsbury, in the County of Monmouth, State of New Jersey, as follows:
