APPOINT TAX COLLECTOR FOR THE TOWNSHIP OF SHREWSBURY

WHEREAS, the Shrewsbury Township Tax Collector, Kelly Montecinos resigned from her position in late December, 2019; and

WHEREAS, the Township Committee advertised for the filling of the aforesaid position and the Personnel Committee consisting of Mayor Edward Nolan, Chief Financial Officer, Thomas Seaman and Attorney, Gene J. Anthony interviewed candidates that submitted their applications for the position on January 11, 2020 including candidates: Ashlesha Deshpande, Leigh Schenck and Theresa Davis; and

WHEREAS, the duties of Tax Collector must be performed by some individual on a daily and weekly basis; and by a person who is properly licensed under State Statute; and

WHEREAS, the Chief Financial Officer has certified that there is sufficient funds available to pay the Tax Collector in performing her duties to the extent of Three Thousand Six Hundred and Fifty Dollars (\$3,650) per year, with an increase to Four Thousand Dollars upon municipal amendment to the salary ordinance. A true copy of said certification is available in the Clerk's Office.

NOW, THEREFORE BE IT RESOLVED, that the Township Committee of the Township of Shrewsbury, County of Monmouth and State of New Jersey, has accepted the recommendation of the Personnel Committee and hereby authorizes the appointment of Theresa Davis as the official Tax Collector for a term of four (4) years commencing January 14, 2020 at a salary of \$3,650 per year, with an increase to Four Thousand Dollars upon municipal amendment to the salary ordinance, to be paid on a monthly basis.

NOW, THEREFORE, BE IT RESOLVED that Julie Martin, Municipal Clerk of Eatontown, and Corinne DiCorica, Deputy Municipal Clerk be appointed as Election Officials of the Township of Shrewsbury for the Primary Election of June 2, 2020 and the General Election of November 3, 2020 at a rate of \$400 per day each for each election, and

BE IT FURTHER RESOLVED, that Julie Martin and Corinne DiCorica are authorized to exercise all the authority and responsibility of the Municipal Clerk/Election Official of Shrewsbury Township on Primary Election Day, June 2, 2020 and General Election Day, November 3, 2020.
