ORDINANCE FOR INTRODUCTION

TOWNSHIP OF SHREWSBURY ORDINANCE #2017-08

ORDINANCE AMENDING ORDINANCE 11.27.12 CONCERNING BOAT AND BOAT TRAILER PARKING AND ESTABLISHING REGULATIONS THEREIN

WHEREAS, the Township of Shrewsbury seeks to establish minimum standards and regulations governing the storage and parking of boats and boat trailers in Shrewsbury Township; and

WHEREAS, this Ordinance amends all prior Ordinances dealing with the storage and parking of boats and boat trailers in Shrewsbury Township and establishes the present and future regulations and standards for such use; and

WHEREAS, this Ordinance specifically amends Ordinance 11.27.12 adopted December 18, 2012 concerning boat and boat trailer parking and establishing regulations therein; and

WHEREAS, certain provisions are necessary to establish enforcement of the regulations and standards governing boat and boat trailer storage and parking in the Township of Shrewsbury.

NOW, THEREFORE BE IT ORDAINED by the Mayor and Township Committee of the Township of Shrewsbury that the following regulations and standards shall exist concerning boats and boat trailers:

Section 1. Parking and Storage on Private Property

No more than one (1) boat and boat trailer shall be allowed to be parked or stored on private property outdoors and such storage shall be in the rear or side yard of any private lot or designated area allowed by the Township Committee by separate Resolution.

Section 2. No person shall park, store or allow to remain on any public street or public parking lot a boat or boat trailer.

Section 3. Upon the declaration of an emergency there shall be no parking upon public streets and parking lots or sections of streets where temporary "emergency no parking" signs are displayed or as authorized by the Township Committee.

Section 4. Enforcement

Any violation of the aforesaid Ordinance may be subject to a fine of not less than One Hundred Dollars (\$100.00) and not greater than Two Thousand Dollars (\$2,000.00).

Section 5. Other Violations

In addition to the fines aforesaid, any boat or boat trailer which is illegally parked may be subject to tow-away by the Code Enforcement Officer with the owner subject to reasonable cost and removal and storage, which may result from such removal before regaining possession of the vehicle.

Whenever any vehicle impounded by virtue of this Ordinance has been ascertained not to be stolen and is certified for junk title and remains unclaimed by any person having the right to possession of such vehicle for a period of ninety (90) days, unless less time is provided by N.J.S.A. 39:10A-1 or other appropriate Statutes, said vehicle shall be sold at public auction under the direction of the Township Committee pursuant to N.J.S.A. 39:10A-1 and/or other appropriate Statutes after notice of such sale has been given at least five (5) days prior thereto by one (1) publication in a newspaper circulated in the Township of Shrewsbury and upon mailing of a copy of said notice to the record owner thereof by regular mail and certified mail, return receipt requested at least five (5) days prior to said sale, if the name and address be known and to the holder of any security interest filed with the Director of the Division of Motor Vehicles. Procedure for sale shall be that provided by the Township Abandoned Vehicle Ordinance.

Section 6. In the event any portion of this Ordinance is stricken by Court for any reason, the remaining provisions of this Ordinance shall remain valid and in force and effect, notwithstanding the stricken provision.

All Ordinances or parts of Ordinances of the Township of Shrewsbury in conflict or inconsistent with this Ordinance are hereby repealed, but only, however, to the extent of such conflict or inconsistencies; it being the legislative intent that all other Ordinances or parts of Ordinances now existing and in effect, unless the same be in conflict or inconsistent with any of the provisions of this Ordinance, shall remain in full force and effect.

The above Ordinance shall be effective upon publication in accordance with the law and subject to approvals, if necessary.

RESOLUTION 2017-106 SUPPORTING BRADLEY BEACH RESOLUTION 2017-180

WHEREAS, the move by the Borough of Bradley Beach to in-house single stream recycling has saved the Borough landfill fees and space, and has made recycling easier for our residents; and

WHEREAS, Monmouth County is the only large-population county in New Jersey that does not have an in-county facility to process recyclables. As a result, the Borough of Bradley Beach is currently paying \$30 to \$40 per ton to process its single stream outside Monmouth County; and

WHEREAS, Monmouth County to have its own facility to process recyclables, the Borough of Bradley Beach would save the sum of \$20 per ton in shipping fees; and

WHEREAS, Monmouth County has long indicated its intention to have a private entity build and operate such a facility at the County's Reclamation Center in Tinton Falls. Monmouth County's intention was to publish a RFP in July of this year for the building of a processing facility in Tinton Falls, however, to date this has not happened; and

WHEREAS, the Environmental Commission of the Borough of Bradley Beach has strongly endorsed the construction of a County recycling facility; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Township Committee of Shrewsbury Township joins in with the endorsement of Bradley Beach and urge the Monmouth County Freeholders, to act expeditiously to publish the construction and operation RFP that will place Monmouth County in the forefront of recycling advancement and environmental protection.

BE IT FURTHER RESOLVED, that the Township Committee of Shrewsbury, County of Monmouth, hereby support the construction of a County recycling facility.

TOWSHIP OF SHREWSBURY RESOLUTION #2017-107

RESOLUTION EXPRESSING OPPOSITION TO LEGISLATIVE PROPOSALS REGARDING THE OPEN PUBLIC MEETINGS ACT AND OPEN PUBLIC RECORDS ACT

WHEREAS, the New Jersey Senate Budget and Appropriations Committee took action on Senate Bill Nos. 1045 and 1046, which amend the Open Public Meetings Act and Open Public Records Act, respectively, on June 29, 2017; and

WHEREAS, the Committee released the bills to the full Senate without recommendation because the bills are unnecessary, unpopular with the public, and would result in significant financial and administrative burdens on municipalities; and

WHEREAS, the bills fail to adequately protect taxpayers, municipalities and, especially, municipal clerks from abusive, harassing, and purposefully confrontational individuals who submit voluminous requests for no legitimate reason; and

WHEREAS, the legislation would expand the Open Public Meeting Act to create impractical and burdensome requirements with respect to subcommittees and working groups established by the entire governing body, which would effectively limit the ability of small groups of local officials discussing issues of public concern for the purposes of informing the governing body; and

WHEREAS, under the bills, the responsibilities of municipal clerks, who the Legislature has already loaded with responsibilities beyond the scope of their office, would be stretched even further than current law requires without a single dollar of additional resources provided to, or authorized to be collected by, municipalities; and

WHEREAS, the bills would impose a financial burden on municipalities that would not be offset by a revenue source other than the property tax, making the bills unfunded mandates prohibited by the New Jersey Constitution; and

WHEREAS, some municipalities are more equipped than others to meet the burdens that would be imposed by Senate Bill Nos. 1045 and 1046, however, without assistance of any kind from the States or the courts, every municipality would be on its own to meet the myriad new requirements of the law.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Shrewsbury, County of Monmouth, that the Legislature is strongly urged to reject Senate Bill Nos. 1045 and 1046 and draft new legislation to modernize OPRA and OPMA while providing municipalities and clerks with the resources to effectuate these changes for the benefit of the public.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be filed with the legislative sponsors of Senate Bill Nos. 1045 and 1046 and Assembly Bill Nos. 2697 and 2699, the Speaker of the General Assembly, the President of the Senate, and the Governor, and all parties are urged to listen to the concerns of local officials and prevent Senate Bill Nos. 1045 and 1046 from becoming law.
