RECREATION: Mr. Brunson stated the gym was shut down by Committee until further notice and he did not have anything else to report.

UTILITIES: Ms. Lettice stated the utility pole was finally taken down with the help of Katrina Thornton. Mrs. Kane stated she made phone calls as well as Ruthie.

# **PUBLIC WORKS REPORT**

December 8, 2020

On a daily basis the municipal building was cleaned and garbage discarded.

Leaf clean up at main building, leaves were removed. Filled potholes on Crawford St. Bought tulip bulbs at Lowes and began planting. Cleaned leaves away from catch basins and picked up all piles. Picked up 2

refrigerators. Set up for voter polling. Put out Veterans day flags. Removed broken poll on Barker Ave and Crawford Street. Installed Handicap spot on Belshaw Ave. Cleaned up leaves in the park. Went and met with Jim about the parking spot in front of his home. Cut and removed old asphalt from in front of 118 Barker Ave. Dumped old asphalt at Stavola and got clean stone. Put clean stone in at 118. Installed new side steps on pickup truck. Picked up asphalt and repaved parking spot at 118. Picked up some soil and seed and repaired next to the parking spot. Picked up no parking signs and polls. Put together no parking signs for the Crawford St project starting on November 23. Started to reduce and shape Kanzan Cherry trees on Barker Ave. Also got no parking digital signs for Crawford Ave. Clean leaves on Crawford St. and cleaned leaves in the park. Fixed hydraulic line on leaf vac. Put hand sanitizing stations at main building. Finished reducing the Kanzan Cherry trees. Made sure leaves were away from catch basins. Cleaned up all leaf piles on road ways. Put up new bathroom soap dispensers, removed old ones and filled holes. Put together air purifiers for main building. Pulled old insulation in conference room. Put together head scanner.

**WHEREAS**, the Borough of Eatontown and the Township of Shrewsbury wish to enter into a shared service agreement for Emergent Fire Protection services for the year 2021; and

WHEREAS, the Borough of Eatontown ("Borough") wishes to provide shared services with the Township of Shrewsbury ("Township") for the provision of Emergent Fire Protection Services, for an annual fee of \$10,000.00 beginning January 1, 2021 and terminating December 31, 2021; and

**WHEREAS,** the Chief Financial Officer hereby certifies the availability of funds in the amount of \$10,000.00.

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Shrewsbury, County of Monmouth, State of New Jersey, that the Mayor is hereby authorized to enter into a shared service agreement, prepared by the Township Attorney with the Borough of Eatontown for Emergent Fire Protection Services for the benefit of Shrewsbury Township commencing January 1, 2021 and ending December 31, 2021 for an annual fee of \$10,000.00.

RESOLUTION AUTHORIZING SHARED SERVICE AGREEMENT BETWEEN NEPTUNE TOWNSHIP AND SHREWSBURY TOWNSHIP FOR MUNICIPAL CLERK SERVICES

WHEREAS, the Township of Shrewsbury is in continued need of a part-time Municipal Clerk to provide services of a Municipal Clerk for Shrewsbury Township; and

WHEREAS, the Uniform Shared Services and Consolidation Act, <u>N.J.S.A.</u> 40A:65-1 *et seq.*, authorizes municipalities to contract with each other for shared services; and

WHEREAS, the Township of Shrewsbury entered into a Shared Service Agreement with Neptune Township on February 12, 2019, through December 31, 2019 and again on January 1, 2020 through December 31, 2021; and

WHEREAS, the Township of Shrewsbury wishes to continue with the Shared Service Agreement with Neptune Township in order to share Neptune Township's Deputy Clerk, Pamela Howard, for one 7-hour day, 8 am to 4 pm (one hour lunch) per week during regular business hours, namely Tuesdays, at an hourly salary to be determined by the Municipal Budget and Salary Ordinance, while allowing Ms. Howard to work privately for Shrewsbury Township under a contract separate and distinct from this Agreement for other hours outside of Tuesday, such as evenings and Saturdays, so as not to conflict with her position in Neptune Township, per the 2021 Salary Ordinance of Shrewsbury Township.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Committee of the Township of Shrewsbury, County of Monmouth and State of New Jersey, that the governing body hereby authorizes the Township of Shrewsbury to enter into a Shared Service Agreement with Neptune Township for the shared services aforesaid and the terms set forth above.

# RESOLUTION AUTHORIZING PROFESSIONAL CONTRACT WITH MASER CONSULTING, PA, TO PREPARE NJDEP ILLEGAL DUMPING PROGRAM APPLICATION

**WHEREAS**, The DEP's Compliance and Enforcement program has developed an Illegal Dumping Program – Collaboration and Deterrence project (IDP – CAD) that will empower municipalities to take an active role in combating illegal dumping; and,

WHEREAS, Twelve Q-Star Technology FlashCam cameras will be distributed to select communities through a competitive process. These cameras will allow communities to improve quality of life for their residents by deterring illegal dumping, identifying perpetrators and providing the evidence necessary to enforce illegal dumping regulations and ordinances. The cameras will be deployed for 10 months to allow ample time for data collection and analysis; in addition to the cameras, the project includes collaboration and training from the Department's Compliance and Enforcement Program and Community Collaborative Initiative and the Office of the Attorney General's Division of Criminal Justice and Division of Law

**WHEREAS**, the Township Committee of Shrewsbury Township is Interested in participating in NJDEP Illegal Dumping Program Collaboration and Deterrence project (IDP – CAD); and,

**WHEREAS**, the Township Committee of Shrewsbury Township has found the need to obtain a professional assessment regarding illegal dumping within the Township of Shrewsbury; and,

WHEREAS, Maser Consulting, PA, will provide assist with an application to the NJDEP illegal Dumping Program for technical assistance, training and loan of Qstar camera to deter illegal dumping and empower municipalities to take an active role in combating illegal dumping at a cost not to exceed \$1550.00 and:

**NOW, THEREFORE BE IT RESOLVED,** that the Township Committee of Shrewsbury Township, County of Monmouth and State of New Jersey, hereby authorizes a contract with Maser Consulting, PA, for assisting with an application to the NJDEP Illegal Dumping Program for \$1550.00; and,
