# AUTHORIZE SHARED SERVICE AGREEMENT BETWEEN THE BOROUGH OF EATONTOWN AND THE TOWNSHIP OF SHREWSBURY FOR EMERGENT FIRE PROTECTION SERVICES

WHEREAS, the Uniform Shares Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq.

authorizes municipalities to contract with each other for shared services; and

WHEREAS, the Borough of Eatontown and the Township of Shrewsbury wish to enter into a

shared service agreement for Emergent Fire Protection services for the year 2020; and

WHEREAS, the Borough of Eatontown ("Borough") wishes to provide shared services with the Township of Shrewsbury ("Township") for the provision of Emergent Fire Protection Services, for an annual fee of \$10,000.00 beginning January 1, 2010 and terminating December 31, 2020; and
