#### **RESOLUTION FOR INCREASING YEAR 2020 TEMPORARY BUDGET APPROPRIATIONS**

WHEREAS N.J.S.A.40A: 4-20 states that in addition to the temporary appropriations necessary for the period prior to the adoption of the budget and regular appropriations, the governing body may, by resolution adopted by a 2/3 vote of the full membership thereof, make emergency temporary appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the fiscal year and the adoption of the budget for said year, and

**WHEREAS** the amount of such emergency appropriation shall be included under the correct heading in the budget as adopted, and

WHEREAS there is a need to provide additional funds for Borough operations, and,

WHEREAS adequate provision for such funding was not made in the temporary budget.

WHEREAS the total emergency temporary resolutions adopted in the year 2020 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A.40A:4-20) including the increase represented by this resolution total \$ 14,000.00, in addition to the temporary budgets adopted January 1, 2020 in the amount of \$352,476.37 and January 30, 2020 in the amount of \$25,052.00 for a Year to Date Temporary Budget of \$391,528.37.

**NOW THEREFORE BE IT RESOLVED** by the Council of the Borough of Shrewsbury (not less than 2/3 affirmatively concurring) that the items of appropriation appearing on the list be included in the temporary budget for the Borough for the year 2020, and that in accordance with the Statute such item of appropriation will be included in the 2020 budget as finally adopted.

**BE IT FURTHER RESOLVED** that two certified copies of this resolution be filed with the Director of the Division of Local Government Services.

# Authorize the County of Monmouth Mosquito Control Division to Conduct Aerial Mosquito Control Operations within the Township of Shrewsbury

**WHEREAS**, the Monmouth County Board of Chosen Freeholders, pursuant to N.J.S.A. 26:9-27 et seq. has elected through its Mosquito Control Division to perform all acts necessary for the elimination of mosquito breeding areas and/or to exterminate mosquitoes within the county; and

**WHEREAS**, the County has instituted an Integrated Pest Management Program consisting of surveillance, water management, biological control and chemical control to exterminate the mosquito population within the county of Monmouth; and

**WHEREAS**, prior to conducting aerial dispensing operations over a designated "congested area", the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 137.51), to secure prior written approval from the governing body of the political subdivision over which the aircraft is to be operated; and

**WHEREAS**, the Township of Shrewsbury is designated as a "congested area" by the Federal Aviation Administration and the County has requested that this governing body consent to its proposed aerial dispensing operations.

#### NOW, THEREFORE, be it resolved as follows:

- 1. The Governing Body hereby authorizes the County of Monmouth Mosquito Control Division or its agent to apply pesticides by aircraft for mosquito control in certain areas of the municipality designated by the County as being either larval mosquito habitat or areas harboring high populations of mosquitoes constituting either a nuisance, a heal hazard, or both with the understanding that:
  - a. the County shall utilize pesticides, application equipment and aircraft that are approved for aerial applications by the applicable Federal (USEPA) and State (NJDEP) agencies, and
  - b. such operations will be performed in compliance with applicable Federal and State regulations, and
  - c. the County will notify the NJ State Police Hamilton Barracks (609) 584-5000 and Mayor Edward P. Nolan (732) 977-3188 over which aerial pesticide operations are planned prior to commencement of such operations.

WHEREAS, the Township experienced a main break on Barker Avenue in November 2019; and

**WHEREAS**, the Public Works Director subsequently informed the Engineer of a non-working hydrant between 15 and 19 Barker Avenue; and,

**WHEREAS**, the Township Engineer has determined that an emergency exists and immediate removal and replacement is needed as the nearest hydrant is 350' south; and,

WHEREAS, the Public Works Director contacted contractors for quotes to make immediate repairs; and,

WHEREAS, Mario's Concrete & Paving Co., Inc. provided a quote of \$8,850.00 to remove and replace the hydrant; and

**WHEREAS**, funds are available in Streets & Roads 0-01-26-290-020 and the Chief Financial Officer has certified in writing;

**THEREFORE, BE IT RESOLVED**, that the Township Committee of the Township of Shrewsbury, hereby declares that emergency conditions exist as the result of a non-working hydrant on Barker Avenue between 15 and 19 Barker Avenue; and,

**BE IT FURTHER RESOLVED**, that based upon the recommendation of the Public Work's Director Mario's Concrete & Paving Co., is hereby authorized to remove and replace a hydrant on Barker Avenue between 15 and 19 Barker Avenue at an amount not to exceed \$8,850.00.
