ORDINANCE FOR INTRODUCTION:

O R D I N A N C E 2019-02

ORDINANCE PROVIDING FOR LOCAL ENFORCEMENT OF THE NEW JERSEY UNIFORM FIRE CODE

WHEREAS, the Uniform Fire Safety Act, (P.L. 1983, c.383) was enacted for the purpose of

establishing a system for the enforcement of minimum fire safety standards throughout the State of New Jersey

; and

WHEREAS, the New Jersey Department of Community Affairs has promulgated minimum fire safety

standards which have been made part of the Uniform Fire Case N.J.A.C. 5:70.1 et seq.); and

WHEREAS, the Uniform Fire Safety Act authorizes municipalities to provide for local enforcement of

these standards and to establish local enforcement agencies for that purpose; and

WHEREAS, it is in the best interest of the citizens of the Township of Shrewsbury to have the Uniform

Fire Code enforced locally; and

WHEREAS, the local fire service as agreed to the plan, which is set forth herein, for the administration and enforcement of the Uniform Fire Code.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Township Committee of the Township

of Shrewsbury as follows:

Section 1. Local Enforcement.

Pursuant to Section 11 of the Uniform Fire Safety Act (P.L. 1983 c. 383), the New Jersey Uniform Fire Code (<u>N.J.A.C.</u> 5:70-1 *et seq.*) shall be locally enforced in the Township of Shrewsbury of Monmouth County.

Section 2. Agency Designation.

The local enforcing agency shall be the Fire Subcode Official or Fire Department which is subject to a Shared Service Agreement through its Bureau of Fire Prevention, which is hereby created therein. The Bureau of Fire Prevention shall hereinafter be known as the Local Enforcing Agency.

Section 3. Duties.

(A) The local enforcing agency shall enforce the Uniform Fire Code in all buildings, structures and premises with the established boundaries of the Township of Shrewsbury other than one and two unit owner-occupied dwellings used exclusively for dwelling purposes and buildings, structures and premises owned or operated by Federal Government, Interstate Agencies or the State.

(B) The Local Enforcing Agency shall faithfully comply with all the pertinent requirements of the Uniform Fire Safety Act and the Uniform Fire Code.

Section 4. Organization.

(A) The Bureau of Fire Prevention established by Section 2 of this Ordinance shall be under the direct supervision and control of a fire official who shall report to the Chief of the Fire Department or Township Clerk.

(B) The Bureau of Fire Prevention shall have at least one paid inspector.

Section 5. Appointment, Qualifications, Term of Office, Removal.

(A) Appointment and Qualifications of the Fire Official or Shared Service Agreement with municipality making such appointment.

(B) Appointment and Qualifications of Inspectors and other employees.

Inspectors and other employees of the enforcing agency shall be appointed by the governing body upon recommendation of the Fire Official. All Life Hazard Use Inspectors shall be certified by the state. This is subject to compliance through Shared Service Agreement as to subparagraphs (C) - (E) below.

(C) Appointment of Legal Counsel.

The governing body shall serve for a term of a minimum of one Year. Any vacancy shall be filled for the unexpired term.

(D) Term of Office.

The Fire Official shall serve for a term of a minimum of one year. Any vacancy shall be filled for the unexpired term.

(E) Removal from Office.

The Fire Official and other employees of the agency shall be subject to removal by the governing body for just cause. Before removal from office, all persons shall be afforded an opportunity to be heard by the governing body or a hearing officer designated by the same.

Section 6. Life Hazard Uses.

The Bureau of Fire Prevention established by Section 2 of this Ordinance shall carry out the periodic inspections of life hazard uses required by the Uniform Fire Code on behalf of the Commissioner of the New Jersey Department of Community Affairs.

Section 7. Non Life Hazard Uses.

(A) In addition to the registrations required by the Uniform Fire Code, the following non life hazard uses shall register with the Bureau of Fire Prevention. These uses shall be inspected once per year (*or once every two, three, four or five years*) and pay an annual fee. The fee schedule amount for each non life hazard use may be amended to fit the needs of the local enforcing agency. The fee is not to be used for life hazard uses as defined in the Uniform Fire Code.

(D) Uses required to register with the State us live hazard uses shall not be required to register under this section.

(E) In the discretion of the Fire Official, vacant buildings will be charged.

(F) All residential uses except R-A uses shall be inspected in the common areas only.

Section 8. Permits and Certificate of Fire Code Status

(A) The application fees for the permits listed in <u>N.J.A.C.</u> 5:70-2.7(b) shall be as provided by State regulation and are currently as follows:

Section 9. Technical Amendments. "Reserved"

Section 10. Board of Appeals.

Pursuant to Sections 17 and 17 of the Uniform Fire Safety Act, any person aggrieved by any action of the local enforcing agency shall have the right to appeal to the County Construction Board of Appeals

<u>Section 11.</u> Enforcement, Violations and Penalties. Enforcement, violations and penalties shall be managed in conformity with the Uniform Fire Safety Act, the Uniform Fire Code and all other laws of the State of New Jersey.

<u>Section 12. Repeals.</u> The following ordinances or portions thereof are hereby repealed: None

BE IT FURTHER ORDAINDED, that all Ordinances or parts of Ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency.

BE IT FURTHER ORDAINED, that the amended Ordinance shall become effective immediately upon its final passage and publication as required by law.

RESOLUTION AUTHORIZING TAX APPEAL SETTLEMENT WITH COOLIDGE SHREWSBURY, LLC

WHEREAS, the Township Committee authorized by Resolution of March 27, 2018 the filing of a Tax Appeal Complaint against Coolidge Shrewsbury, LLC with regard to Block 1, Lot 2; Block 2, Lot 1 and Block 2, Lot 3, which was determined by the Tax Assessor to be less than the true or assessable value for the aforesaid property, and sought a Judgment to increase the assessments of said Blocks and Lots to the correct assessable value; and

WHEREAS, the Tax Assessor and the Township Attorney and the attorney for Coolidge

Shrewsbury, LLC reached a settlement in the aforesaid matter, a true copy of said Stipulation of Settlement is

attached hereto and made a part hereof as Exhibit "A," increasing the total original assessment from

\$14,400,000.00 to \$15,400,000.00 for the year 2018; representing an estimated tax rate of 2.559% or an

increase in additional taxes of \$25,590.00; and

WHEREAS, the parties have entered into a Letter Agreement with regard to the years 2019,

2020 and 2021 wherein the aforesaid assessment shall be increased in 2019 to \$16,267,000.00; in 2020 to

\$18,134,000.00 and in 2021 to \$20,000,000.00; representing an increase in assessment in 2019 of

\$1,435,000.00; in 2020 of \$2,857,040.00 and in 2021 of \$4,264,731.00; for an increase in additional taxes for

2019 of \$37,640.00; for 2020 of \$76,813.00 and for 2021 of \$117,526.00 for a grand total of additional taxes

between 2018 and 2021 of \$257,569.00.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Committee of the Township of Shrewsbury, County of Monmouth and State of New Jersey, that the governing body hereby authorizes the Township Attorney, Gene J. Anthony, Esq. and the Tax Assessor, Jay Briscione, CTA, to execute the aforesaid Stipulation of Settlement attached hereto and made a part as Exhibit "A" and the Letter Agreement for the years 2019, 2020 and 2021 with regard to Coolidge Shrewsbury, LLC with property located at 74A Crawford Street, Block 1, Lot 2; Block 2, Lot 1 and Block 2, Lot 3.

A RESOLUTION AUTHORIZING THE TOWNSHIP OF SHREWSBURY TO PARTICIPATE IN INTRA-COUNTY MUTUAL AID AND ASSISTANCE AGREEMENTS WITH PARTICIPATING UNITS IN THE COUNTY OF MONMOUTH

WHEREAS, the Uniform Shared Services and Consolidation Act, <u>N.J.S.A.</u> 40A:65-1 *et seq.*, ("Act") provides that any local governmental unit may enter into a contract with any other local governmental unit to provide or receive any service that each local unit is empowered to provide or receive within its own jurisdiction; and

WHEREAS, mutual aid and assistance agreements between municipalities, counties, law enforcement agencies, police, emergency medical service, fire departments, fire companies, or EMS organizations and fire departments situated in fire districts operated by a Board of Fire Commissioners, are permitted pursuant to <u>N.J.S.A.</u> 40A:14-26 and 40A:14-156.1; and

WHEREAS, the President in Homeland Security Directive (HSPD-5), directed the Secretary of the Department of Homeland Security to develop and administer a National Incident Management System ("NIMS"), which would provide a consistent nationwide approach to Federal, State, local and tribal governments to work together more effectively and efficiently to prevent, prepare for, respond to and recover from domestic incidents, regardless of cause, size or complexity; and

WHEREAS, "The New Jersey Civilian Defense and Disaster Control Act" App.A9-33 et seq.,

provides for the health, safety and welfare of the people of the State of New Jersey during any emergency by centralizing control of all civilian activities having to do with such emergency giving the Governor control over the resources of each and every political subdivision to cope with any condition that shall arise out of such emergency; and

WHEREAS, the Director of the Division of Fire Safety in the Department of Community Affairs promulgated rules in accordance with the "Fire Service Resource Emergency Deployment Act, " <u>N.J.A.C.</u> U52:14E-11 *et seq.*, commonly referred to as the "Fire Service Resource Emergency Deployment Regulations" <u>N.J.A.C.</u> 5:75A *et. seq.*; and

WHEREAS, the Mayor and Township Committee of the Township of Shrewsbury deem it to be in the best interests of the Township of Shrewsbury to enter in to Mutual Aid and Assistance Agreements with governmental agencies throughout Monmouth

County and all of their departments, authorities, boards, commissions and other functions under the auspices of each participating governmental entity including but not limited to, law enforcement, public works, emergency medical services, emergency management, human services, hazardous materials response units technical or special operations teams, Community Emergency Response Team ("CERT") members, Medical Reserve Corps

("MRC") members or other volunteers and other jurisdictions defined "local governments" in the Homeland

Security Act of 2002; and

WHEREAS, N.J.S.A. 40:14-26 and 156.1 et seq., has authorized interjurisdictional mutual aid;

and

WHEREAS, the Mayor and Township Committee of the Township of Shrewsbury and the

Participating Units recognize the benefit of entering into an Agreement for mutual aid and assistance with each

other to protect against loss, damage or destruction by fire, civil unrest, hazardous material, major criminal or

emergency events, natural and man-made disaster or catastrophe, and to address those situations when

additional aid and assistance is needed to protect the best interests of the persons and property of each

individual jurisdiction.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Committee of the Township of Shrewsbury, County of Monmouth and State of New Jersey, that the Intra-County Mutual Aid and Assistance Agreements between the Township of Shrewsbury and Participating Unites be and are hereby accepted.

BE IT FURTHER RESOLIVED, that the Township Clerk forward a true copy of this resolution to the Monmouth County Sheriff, Office of Emergency Management Coordinator, State Police and Fire Chief of the Borough of Shrewsbury.

RESOLUTION FOR INCREASING YEAR 2019 TEMPORARY BUDGET APPROPRIATIONS

WHEREAS, N.J.S.A. 40A:4-20 states that in addition to the temporary appropriations necessary for the period prior to the adoption of budget and regular appropriations, the governing body may, by resolution adopted by a 2/3 vote of the full membership thereof, make emergency temporary appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the fiscal year and the adoption of the budget for said year, and,

WHEREAS, the amount of such emergency appropriation shall be included under the correct heading in the budget as adopted, and;

WHEREAS, there is a need to provide additional funds for Township operations , and,

WHEREAS, adequate provision for such funding was not made in the temporary budget,

WHEREAS, the total emergency temporary resolutions adopted in the year 2019 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A.40A:4-20) including the increase represented by this resolution total \$6,000, in addition to the temporary budgets adopted January 8, 2019 in the amount of \$225,670.46 and emergency appropriation of February 12, 2019 of \$131,810.68 and March 12,, 2019 of \$180,875.00 for a total Year to Date Temporary Budget of \$544,356.14.

NOW, THEREFORE BE IT RESOVED, by the Council of the Township of Shrewsbury (not less than 2/3 affirmatively concurring) that the items of appropriation appearing on the list be included in the temporary budget for the Township for the year 2019, and that in accordance with the Statute such item of appropriation will be included in the 2019 budget as finally adopted.
