NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Shrewsbury (not less than 2/3 affirmatively concurring) that the items of appropriation appearing on the list be included in the temporary budget for the Township for the year 2021, and that in accordance with the Statute such item of appropriation will be included in the 2021 budget as finally adopted.

WHEREAS, State of NJ P.L. 2020, Chapter 74, Section 1 amends N.J.S.A 40A:4-26 to state that "when a public health emergency pursuant to the "Emergency Health Powers Act," P.L.2005, c.222 (C.26:13-1 et seq.), or a state of emergency, pursuant to P.L.1942, c.251 (C.App.A:9-33 et seq.), or both, has been declared by the Governor in response to COVID-19, the Director of the Division of Local Government Services may promulgate general guidance modifying the standard for anticipated revenues when the amount realized in cash from the same source during the next preceding fiscal year experienced reductions due to COVID-19."; and.,

WHEREAS, the Director of the Division of Local Government Services has issued guidance allowing for the use of a three-year average of prior year revenue realized for miscellaneous revenues anticipated in the 2021 budget; and,

WHEREAS, the need to use the three-year average method to compute certain anticipated revenues in the 2021 Budget Year is beneficial to the Borough, as well as necessary; and,

WHEREAS, the selected anticipated revenues, and the three-year average amounts are as follows:

Miscellaneous Revenue Anticipated Average Revenue Realized – Prior 3 Years (Maximum Allowable in 2021 Budget)

New Business:

Mayor Puhak stated the situation with the watermain breaks have come to a heard and he's sick of it. He stated Maser has made a proposal and He wanted to vote on it. He stated he wanted to make it a huge priority.

Mr. Anthony stated the proposal by Maser required several steps. He asked if he's spoken to the CFO as to where they would get the money. He stated he thought the Township was capped out as far as bonds were concerned and the only other choice is to do an emergency appropriation.

Mayor Puhak stated enough was enough. He was concerned that this would lower the value of the residents property and no one would want to move into the Township.

Mr. Anthony stated he would have to speak with Tom Seaman and Bill White regarding this.

Public Portion:

James Vervoort 117 Barker Avenue stated at the last meeting discussion was made regarding the access road being paved.

Mayor Puhak stated he did not think that would be done.

Mr. Anthony stated Mr. Wall has been asking for a better gate. He stated they did not have plans to pave that area. He stated Mr. Walls concerns were that people were dumping and that we should get a better gate.

Mr. Vervoort stated if you open that road up tons of water would come rushing through. He stated bigger pipes and storm drains would have to be put in.

Mr. Wall stated he did not perceive leaving an opening because people would still go through. He stated they needed a recess curb like it's handicap. It eliminates 5ft opening.

Mr. Anthony stated quotes would be needed for gates.

Robin Kane, 84 Belshaw thanked Mr. Wall and Deputy Mayor Jennings for being out and helping with the main break. She stated as far as the water line NJAWC was thinking of making us as part of a pilot plan.

Mr. Anthony stated they've been discussing that win Senator Vin Gopal.

Mrs. Kane also stated the ambulance was a major issue. She stated two weeks a go a neighbor past away and RWJ showed up with their ambulance. It took a half and hour to forty five minutes for help. She died and was only 36 years old.

Mr. Anthony stated he had a meeting win Senator Gopal and RWJ and they gave him an agreement that they would do it because he was in talks with Tinton Falls North. He stated a lot of ambulance have closed because of the lack of volunteers. He stated all the ones he contacted could not do it.

Mrs. Kane stated that by the Township not having a squad is a liability.

Mr. Anthony stated it is only if they do not do anything and he's looking to get someone and pay them.

Katrina Thornton stated they were working on the lights between 75 Barker and 96/98 Belshaw. She stated Mr. Wall was looking for Solar.

Mr. Wall stated he would look into it tomorrow.

Theresa Meire, 18 Belshaw questioned the status of creating a pollinator in Nagle park.

Mayor Puhak suggested putting it in the Center Island.

Ms. Meire stated it was not as ideal as the field but she could water it and put wild flower there

Mr. Anthony stated this would fall under building and Maintenance and suggested she speak with Mr. Wall and Mrs. Lettice so that they could all meet.
