Wednesday - Charles Brandon Metz - 7 am - 3 pm

Thursday - David Dasher - 7 am - 3 pm

Friday – Charles Brandon Metz – 7 am – 3 pm

- 2. Both employees of the Public Works Department shall be on call on weekends for emergency contact. In an emergency, Charles Brandon Metz will respond first and then David Dasher, if needed.
- 3. The Public Works Employees will cover each other in case one is out based on sick leave.
