VVHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Township of Shrewsbury has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2021 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Township of Shrewsbury that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.
- 3 et seq., are fully met (complies with CAP law). 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law: a. All estimates of revenue are reasonable, accurate and correctly stated, b. Items of appropriation are properly set forth c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

# RESOLUTION ADOPTING THE MONMOUTH COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN

WHEREAS, the Township of Shrewsbury, NJ, has experienced natural hazards that result in public safety hazards and damages to private and public property and;

WHEREAS, the hazard mitigation planning process set forth by the State of New Jersey and the Federal Emergency Management Agency offer the opportunity to consider natural hazards and risks, and to identify mitigation actions to reduce future risks and:

WHEREAS, the New Jersey Office of Emergency Management has provided federal mitigation funds to support development of an updated mitigation plan and;

Whereas, a Multi-Jurisdictional Hazard Mitigation Plan has been developed by the County Office of Emergency Management and Mitigation Planning Committee and;

Whereas, the Multi-Jurisdictional Hazard Mitigation Plan includes a prioritized list of mitigation actions including activities that, over time will help minimize and reduce safety threats and damage to private and public property and;

WHYEREAS, the draft plan was provided to each participating jurisdiction through a website hosted by Michael Baker International, the contracted vendor assisting with the planning process. Links were links also posted on the Emergency Management and Division of Planning websites so as to introduce the planning concept and to solicit questions and comments and to present the Plan and request comments, as required by law and;

NOW, THEREFORE BE IT RESOLVED by the Township of Shrewsbury:

- 1. The Monmouth County Multi-Jurisdictional Hazard Mitigation Plan, as submitted on June 23, 2020 by the Monmouth County Office of Emergency Management to the New Jersey Office of Emergency Management and the Federal Emergency Management Agency and subsequently approved by both agencies on August 27, 2020, be and is hereby adopted as an official plan of the County or Monmouth; with the required yearly updates and minor revisions recommended by the Federal Emergency Management Agency and/or the New Jersey Office of Emergency Management may be incorporated without further action.
- The Township of Shrewsbury departments identified in the Plan are hereby directed to further pursue potential or suggested implementation of the recommended high priority activities that are assigned to their departments.
- Any action proposed by the Plan shall be subject to and contingent upon budget approval, if
  required, which shall be at the discretion of the Township of Shrewsbury and this resolution shall
  not be interpreted so an to mandate any such appropriation.
- 4. The Township of Shrewsbury Emergency Management Coordinator is designated to coordinate with other offices and shall periodically report on the activities, accomplishments, and progress, and shall prepare an annual progress report to be submitted to the New Jersey Office of Emergency Management. The status reports shall be submitted on a yearly basis by a predetermined date agree upon by all stakeholders.

BE IT FURHER RESOLVED that the Township Clerk forward a certified true copy of this resolution to the Monmouth County Office of Emergency Management Coordinator and the Shrewsbury Township Emergency Management Coordinator.

# RESOLUTION COMMENCING PROCEDURE FOR SALE OF THE SHREWSBURY TOWNSHIP WATER SYSTEM UNDER THE WATER INFRASTRUCTURE PROTECTION ACT DUE TO THE EXISTENCE OF EMERGENT CONDITIONS

WHEREAS, the Water Infrastructure Protection Act, based on a Resolution adopted by a two thirds majority of the Township Committee verifying an emergent condition exits, allows a process that ultimately leads to the sale of the municipal water system; and

WHEREAS, the Township Committee is undergoing drastic measures due to the ancient water system leading to water main breaks almost on a monthly basis, and is in need of emergency measures to address the water infrastructure problems; and

WHEREAS, William White, Engineering Consultant for Colliers Engineering and Design, flk/a Maser Engineering, shall supervise the process, perform evaluation and report on the value of the water system and impact of transaction on the residents as well as financial requirements, administer testimony of the report at a public hearing, assist with advertising the request for qualifications and request for proposals concerning the purchasing of the water system; a proposal that is expected to cost in soft costs approximately \$88,000.00; which the Chief Financial Officer, Thomas X. Seaman indicates can be financed through public bonding.

NOW, THEREFORE BE IT RESOLVED, that the Mayor and Township Committee of the Township of Shrewsbury hereby finds that emergent conditions exist with regard to the deterioration of an approximately 80 year old plus water infrastructure and that it hereby authorizes William White of Colliers Engineering and Design, f/k/a Maser Engineering, to commence the process allowing for the ultimate sale of the Shrewsbury Township water system to an appropriate bidder. A true copy of said proposal for professional services is attached hereto and made a part hereof as Exhibit A.

BE IT FURTHER RESOLVED, that the cost of this process is not to exceed \$88,000.00 and shall be financed by bonding undertaken by the Chief Financial Officer, Thomas X. Seaman, and Bonding Attorney and approved by appropriate subsequent Resolution or Ordinance.

Ruth Carll, 28 Barker Avenue questioned the plan to repair paving for the last two water main

Mr. Anthony stated he was not sure if it was subject to capital improvements.

Ken Wall stated the paving company said the asphalt has to settle.

Ms. Carll questioned whether she could remove the cones and park in front of her home.

Mr. Wall stated he would remove the cones.

Donna Johnson 6 Barker Avenue addressed the Committee and raised concerns regarding the proposed pollinator garden.

Mr. Anthony stated the person that proposed it has not called back.

Ms. Johnson also raised concerns regarding remodeling of an apartment at Shrewsbury Arms. There was a large pile of garbage and debris in front of the building.

Mr. Anthony stated that would be a code violation and asked Mr. Wall to contact the code officer.

Ms. Johnson stated code enforcement officer should be inspecting the back of the stores. She addressed the debris that was on the dirt road from last year and stated it was a hire hazard.

Mr. Wall stated the previous employees who worked for the Township authorized the dumping and he was trying to clean it up today.
