RECREATION REPORT: Richard Brunson, Recreation Director, 2 Crawford Street, gave a list of events that he wanted to do and stated Katrina Thornton provided a list of events.

MUNICIPAL ATTORNEY REPORT: Mr. Anthony stated he talked to Tom Welsh about the pooper scooper law and dog waste ordinance and he gave him the same answer that he gave them and that is the ordinance would be hard to enforce unless he was to see it happen. The State Police could enforce it but they only come in occasionally. He could do a leash ordinance and push for enforcement of the pet waste ordinance and Mr. Welsh could only do what he can but he can only do it if he were to see it or someone was willing to testify in court. Mr. Anthony

stated he would like to see what other municipalities had in place. He also questioned what was the Committee looking for as far as amending the parking ordinance.

Bill Spengeman, 143 Belshaw, stated it was to authorize the Committee to approve handicap parking applications rather than the Director of Public Works and the Business Administrator.

Mr. Anthony stated he felt that it should be approved by the Township Committee because there was no Business Administrator and by the Township Committee approving it things might move a little bit slower. He will amend it to be more practical to today. He also stated they would have to do a walk through for proper signage as well.

HOUSING INSPECTOR/CODE ENFORCEMENT: Mr. Anthony stated he spoke to Tom Welsh and he's trying to figure out how to do the parking ordinance but was confident there won't be a problem.

PUBLIC HEARING -2019 MUNICIPAL BUDGET -

Thomas X. Seaman, C.F.O. stated this year the Township was under local exam of the State and that happens every three years. He was in contact with the State last week and they had a couple of little minor changes. They gave the Township Committee the approval to adopt the budget tonight. He stated the budget has a total of \$816,316.14, an increase from last year which is mostly attributed to the debt service increase. The tax increase is up \$37,000 and debt service increase is over \$37,000. He tried to keep all of the operating expenses, the salaries increased some what, operating expenses increased a little, sewer cost increased somewhat, pension cost decreased by \$5,000 and shared services increased by \$12,000 but was offset by less salaries. He stated what he tried to do while working with the Mayor and Committee was to look at shared services and they tried to do as little of a tax increase as possible and meet the needs of the community. Overall the evaluation of the town increase this year based on the appeal that happened in town increased by over 3% and possibly our tax rate depending on what the County comes in will be about 3%. Our municipal portion fee increased by about 4% but overall the tax increase might not affect everyone. He stated he was not sure how it would work with the apartments and if they would be affected directly.

Mr. Anthony stated the Township had rent control and they cannot raise the rent above the CPI no matter what happens with taxes unless they come before the rent board requesting a hardship increase.

Mr. Seaman stated overall we have a pretty good budget.

Mayor Nolan offered a motion for open Public Hearing, moved and seconded by Mr. Jennings; all were in favor.

Robin Kane questioned what was the percentage of the increase.

Mr. Seaman stated a little over 4% for the municipal portion and for the school and county around 2%. He doesn't have a final number but with the overall increase with evaluation going

up the tax rate may be a little less. It will be finalized when the County certifies our tax rate in July.

Mr. Seaman also stated the Township Committee had a Capital Budget as well, a grant. The Township has a health Capital Fund Budget that's in good shape.

Mrs. Kane questioned why the pension benefits decreased.

Mr. Seaman stated the County gave us a bill and it went down.

Mrs. Kane questioned where did the Township purchase their fuel.

Mayor stated it was purchased from the County.

Mayor Nolan offered a motion to closed the hearing, moved and seconded by Mr. Jennings; all were in favor.

Mr. Anthony suggested talking with Mr. Puhak at the next meeting.

Mrs. Kane thanked the Committee for getting the fire outage taken care of so quickly but stated there was no traffic control and questioned why the State Police did not show up.

Mayor Nolan stated they did not even respond when Shrewsbury Boro called and he was out there trying to control the traffic and was totally ignored by JCP&L.

Mr. Anthony stated they would have to speak with the new representative for JCP&L.

Mrs. Kane suggested speaking with the State Troopers as well. She also questioned why there was payment on the bill list for two elections clerk's for the primary because they've never paid two people before.

Mr. Anthony stated one was the Municipal Clerk and the other the Deputy Clerk and since Ms. Howard is the Deputy Clerk in Neptune, she and the Clerk have to operate in Neptune the day of the elections. He stated the Deputy Clerk has to be available in the event that something goes wrong.

Ms. Howard stated this was done last year as well.

Mrs. Kane questioned the work that Quality Electric would be providing

Mr. Anthony we just signed the contract on that and Quality Electric has to remove certain fixtures for JCP &L.

Mrs. Kane do you have a date on the upgrade.

Mr. Anthony stated they will do it whenever they have the schedule to start.

Mayor Nolan stated Atlantic Tree was tentatively June 10th and Quality has to do it before.

Mrs. Kane questioned how many people would be impacted when they cut the power lines down on Crawford and will the VMA impacted also because they are all connected.

Mayor Nolan stated they would cut it by the little store so that it is isolated and the only thing that would be out would be the street lights and the garage.

Mrs. Kane questioned which part of Barker would the grant be applied to.

Mayor Nolan stated around the median strip.
