Ayes - Ms. Lettice, Mr. Jennings and Mayor Puhak.

Rich Osis congratulated Lynda Lettice on her appointment and reiterated that he wanted the County Freeholders to help them. He stated the Township needed a voice and someone to speak on behalf of the residents of Shrewsbury Township.

Ruth Carll, 28 Barker Avenue, stated she has a background in grants and would like to volunteer in a capacity that would help the Township. She also questioned whether the Township had a Strategic Plan.

- T.J. Pingitore, 111 Barker Avenue stated he's been a resident for 2 ½ years. He discussed the break-ins throughout the Township and stated he would like to volunteer to create a Strategic Plan and Safety Plan. He questioned whether there was a way to have cameras go up and have neighborhood watch signs. He suggested having cameras on the front pole going in and out where it would not invade the residents privacy.
- Mr. Anthony stated it would have to be investigated by the Township Committee.
- Mr. Pingitore questioned which Committee person was in charge of OEM.
- Mr. Anthony stated he sent a letter to the State Police.
- Mr. Pingitore questioned how was the crime reports being reported to the Committee.

- Mr. Anthony stated the State Police provided it then they stopped. He stated his plans to see where they are and he's sent them several letters.
- Mr. Pingitore questioned the status for shared service for EMS.
- Mr. Anthony stated he sent a letter to Tinton Falls North. He gave the background of services provided.
- Mr. Pingitore questioned who did he speak to.
- Mr. Anthony stated he spoke to the Commander.
- Mr. Pingitore questioned the status of the State Police having barracks in the Township.
- Mr. Anthony stated there wasn't enough technology here for them to have a substation.
- Mr. Pingitore questioned whether the Township would be willing to apply for grants and if there was a list for emergency preparedness of residents with special needs and if so, is a plan in place.
- Mr. Anthony stated that Tom Welsh does that and can be contacted.
- Mr. Pingitore questioned when was the last time the poles were inspected.
- Mayor Puhak stated the electrical system was his top priority.
- Mr. Anthony stated we own a lot of the poles but not all of them.
- Mr. Pingitore questioned whether the Township had a business administrator.
- Mr. Anthony stated the Township of Shrewsbury was a unique Town that did not necessarily need a business administrator. He stated they did however have one three years ago.

Robin Kane, 84 Belshaw Avenue, questioned whether the Township has tried to use Oceanport for EMS.

Mr. Anthony stated they did not reply.

Mrs. Kane stated the electric was being worked on for AVMA along with the Township and there is only a certain amount the Township can do without raising taxes. She thanked Brandon for bulk pick up. She stated he was doing a phenomenal job.

Ms. Carll stated she felt the Township needed a Business Administrator position so that it could be managed and have someone who cares.

Rich Osis, discussed garbage and grass growing throughout the Township. He stated he did not want it to look like a junk year.

Bill Spengeman, 143 Belshaw suggested turning vents off and opening doors for the next meeting.

Mr. Pingitore stated he was interested in becoming a business administrator or mayor to help bring cohesiveness to the Township

AJ VerVoort, 117 Barker Avenue, stated if the Township must make the police held accountable because black lives matter.

Ms. Thornton stated there were parents who did not want their kids on videos at the playground. They did not want police in the building but in a trailer. They didn't want it in the building due to kids. They wanted it outside in a trailer. She stated she started a newsletter but COVID happened.
