AN ORDINANCE CREATING THE POSITION OF PUBLIC WORKS PERMANENT PART-TIME AND FIXING THE COMPENSION OF OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF SHREWSBURY, COUNTY OF MONMOUTH, STATE OF NEW JERSEY FOR THE CALENDAR YEAR 2014

WHEREAS the Township Committee of the Township of Shrewsbury desires to create the position of Public Works Part-time, and

WHEREAS the Township policy states "no person shall be employed or promoted unless there exists a position created by ordinance, adopted by the Mayor and Township Committee of the Township of Shrewsbury as well as funded through the necessary budget appropriations and salary ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Shrewsbury, in the County of Monmouth, State of New Jersey that the position of Public Works Permanent Part-time is hereby created; and

BE IT FURTHER ORDAINED by the Township Committee of the Township of Shrewsbury, County of Monmouth and State of New Jersey, that the annual salary and compensation of the officers and employees holding the office or positions hereinafter described shall be effective from January 1st, 2014.

All minimum salaries set forth above shall be the fixed minimum salary to be earned by each officer or employee of the Township of Shrewsbury. Each officer or employee may receive a cost-of-living/merit increase of up to two percent (2%) of the officer's or employees' annual salary per the discretion of the Township Committee.

(a) The Township Committee shall consider the issue of cost-of-living/merit pay salary increases and recommend a cost-of-living/merit pay salary increase for any officer or employee of the Township of Shrewsbury by passage of this ordinance.

(b) Increases shall not exceed two percent (2%) of the officer's or employee's annual salary (i.e., the maximum salary set forth above). Except where otherwise

(c) Shall be retroactive to January 1, 2014.

The within salary ordinance hereby supercedes and amends any and all prior salary ordinances enacted by the Township of Shrewsbury.
